(vi) Computer is optional for class IX to XII. Computer fee for class IX-X is Rs.600/- p.m. and for class XI,XII is Rs-700/- p.m.

Note:

- Fee will be deposited from 1st to 10th day of every month. In case of late fee from 11th to 19th day a sum of Rs-25/- and 20th to 30th a sum of Rs-50/ will be charged. Cheque regarding fee will be accepted from 1st to 8th day of every month. Cheque Bounce charges will be Rs-300/-

 - (ii) In case fee is not deposited till the last day of the month, students name will be struck off and Rs-300/- will be charged as Re-Admission Fee.
 - (iii) The amount decided by the council/Board for Registration fee (Class IX)& Board Fee (Class X & XII) will be payable by the parents. Eligibility Fee & Charges for the correction of entries (if any) T.C. etc: will be payable by the parents.
 - (iv) Candidate participating in any of School Function/Activity will be liable to pay amount for costume & other accessories. A prior consent of the parents will be sought for the same.
 - (v) The financial session is divided into two terms. The first terms is from April to September and the second term is from October to March. Once a student has attended the school even for one day in any of the above two terms, and if he/she wants to leave the school, then He/she is liable to pay fees for the entire remainder of that term too.
 - (vi) Full 12 months Fees of the entire session of 2019-2020 can also be accepted in advance if the parents so desire.
 - (vii) There is no provision for concession in fee.
